Re.: Water Supply by Delhi Jal Board

Of late we are getting erratic supply of water from MCD, Delhi Jal Board on daily basis. Sometimes it is normal and sometimes it gives us jitters to us as to whether we will be able to provide water to the residents to meet their daily requirement. In this connection news has also appeared prominently in leading newspapers that Haryana Government has stopped supplying its normal quota to Delhi Government. Delhi Jal Board does not have enough water in the reservoir to cater needs of Delhi citizens for long till the dispute between Haryana and Delhi is sorted out. Thus there is a water crisis in Delhi and it has come to our notice that some of the societies in Rohini are using borewater to meet the needs of their residents. As such all the residents are requested to use water judiciously by adopting following:-

1. Turn off the tap while washing utensils in the kitchen.
2. Turn off the tap while washing clothes.
3. Turn off the tap while shaving.
4. Take bucket for bath instead of using shower.
5. Use half flush for daily nature call.
6. Use bucket for washing car instead of hosing it down.
7. Used mop water can be used to water plants and gardening.


